USDA PASSES RESOLUTION SUPPORTING "LIVE LIVELY – SQUARE DANCE" LOGO & SLOGAN

At the Annual Meeting on June 24, 2015, the USDA Board of Directors adopted a resolution in support of the re-imaging effort promoted by the Alliance of Round, Traditional, and Square Dance (ARTS-Dance). As part of this effort to modernize the image of square dancing, ARTS-Dance has presented a logo and slogan that they are encouraging square, round, contra, and related dance organizations to use in all publications, educational materials, and promotional items. The logo and slogan are intended to present a newer, more modern image to the public to support local, state, and national promotion and recruitment activities.



The USDA resolution, which can be found in full on the attached page, notes that square dancers everywhere acknowledge the need to achieve greater recognition and acceptance of the activity. The resolution also points out that a united effort – centered around common use of a single, recognizable symbol and slogan – can help achieve more universal awareness. The resolution concludes:

Be it resolved that the UNITED SQUARE DANCERS OF AMERICA encourages its Affiliates, and their member organizations, to support the new Square Dance Logo and Slogan by revamping all of their publications and promotional materials incorporating the logo and slogan to reflect the modern image of the new Live Lively – Square Dance – Logo and Slogan.
