Nov 78	The idea for a national square dancer's association was presented to the California Square Dance Council. It was the intent of this idea to bring together the various State Square Dance Associations, Councils, Federations, etc. into one National organization to represent the Dancers in the affairs of the activity.												
Feb 79	Jim & Jan Maczko (CA), as President of the California Square Dance Council, were directed to contact all of the State organizations throughout the country to see if there was any interest in organizing a National Square Dance Body. Questionnaires were sent out and a very good response was received.												
28 Jun 80	<p>A meeting was held in Memphis, TN at the 29th National Square Dance Convention and brought more than 100 dancers from 12 states together to create the "Organizing Committee for the Formation of a National Square Dancers Association." 1 Nov 80	A group of interested dancer/leaders met in Oklahoma City, OK to formulate the governing documents for USDA - Constitution, By-Laws and Standing Rules for distribution in early 1981 to all State Associations, Federations, Councils, etc. for their review and comment. It was proposed to have an organizational meeting in Seattle, WA in June 1981 to officially form the national dancer's organization.												

26 June 1

**Organization Meeting and final adoption of the organizational documents to officially create a National Square Dancer's Organization took place at the Washington Plaza Hotel, Seattle, WA during the 30th National Square Dance Convention.**

**A list of organizational names was presented and the name "UNITED SQUARE DANCERS OF AMERICA, Inc." was chosen as the official name at the 1st Annual Meeting with 22 states represented. The states represented approximately 110,000 dancers.**

**Three Resolutions were adopted, one creating the UNITED SQUARE DANCERS OF AMERICA, INC. and directing the elected Officers to execute drafts of the Constitution, By-Laws and apply for a Charter of Incorporation under the laws of the United States. Another Resolution supported the efforts of the California based "National Folk Dance Committee" in their efforts to obtain recognition for Square Dancing as the National Folk Dance. The third Resolution encouraged the California based "Square Dancers of America" in their endeavors to promote Square Dancing through presentation of an annual float in the New Years Day Tournament of Roses Parade in Pasadena, CA.**

**Following goals were established:**

- 1. Assist the National Folk Dance Committee in their efforts to obtain recognition of square dancing as the National Folk Dance.**
- 2. Support the efforts of the Square Dancers of America in their endeavor to bring Square Dancing to the attention of the general public through placement of a float in the name of Square Dancers in the annual Tournament of Roses Parade.**
- 3. Strive for the unification of the dancer.**
- 4. Provide a National Square Dancers insurance program for dancers, clubs and affiliate groups desiring coverage.**
- 5. Establish lines of communications and cooperation with existing national organizations on behalf of the Square Dancer.**
- 6. Be available to provide assistance to those desiring to organize for the betterment of the Square Dance Activity.**
- 7. Develop a National program for the recognition of the Square Dance Leader for their services to the movement.**
- 8. Serve to promote Square Dancing in all possible areas.**
- 9. Obtain the history of the various affiliate members to create an overall record of the development of the Square Dance Organization.**

10. **Maintain lists of the numerous Square Dance Organizations, Publications, etc. to further enhance the cooperation among these various groups.**

**26 Oct 81**

**USDA letter issued to the square dance world announcing the creation of USDA and inviting dance organizations to affiliate with USDA. Copies of the organizational documents: Constitution, By-Laws, Standing Rules, a Press Release for use in any square dance publication, and a sample resolution indicating a desire to Affiliate as a Charter Member of the USDA were also provided.**

**Charter Membership granted to those Organizations that qualify and join the USDA between June 26, 1981 and June 25, 1982.**

**30 Jan 82**

**First Winter (Mid-Year) USDA Executive Board Meeting held at PASARDA Square Dance Hall in Fort Walton Beach, FL. PASARDA Hall is a square dance hall owned and operated by the Playground Area Square and Round Dance Association, Inc.**

**The first five applications for affiliation from Alabama, Arkansas, California, Colorado and Missouri were reviewed and recommended for acceptance by the USDA Board of Directors.**

**An economical square dancers medical/liability insurance program was presented which could provide the individual dancer with accident-medical coverage as well as the club, area and State Organizations with \$1,000,000 general liability insurance for those organizations desiring to participate.**

**Reaffirmed the 10 USDA goals established at the June 26, 1981 USDA Organization Meeting.**

1 Jun 82

USA President R. Reagan signed a Bill identifying Square Dancing as the National Folk Dance for a 2-year period through 1983. Efforts are now being directed toward the State level, seeking each State to also designate Square Dance as its official State Folk Dance.

Celebrations were held nationwide by dance organizations.

25 Jun 82

USDA Annual Meeting, Detroit, MI.

Resolution adopted that USDA supports the 1982 CALLERLAB resolution to encourage cooperation among the national and international square dance organizations: CALLERLAB, LEGACY, ROUNDALAB, USDA, NSDC, National Association of Square and Round Dance Suppliers, etc. involving dancers, leaders, callers, and round dance instructors who contribute to the establishment of the direction and advancement of square dancing in all its forms.

An economical National Insurance Program for Square Dancers, clubs, associations and State organizations was approved.

Resolution adopted that USDA establish a Square Dancers Museum and a Square Dancers Hall of Fame. USDA to establish a committee to develop plans and programs to develop a Square Dancers Museum and Hall of Fame at some future date.

**Acceptance of the 11 Charter Memberships established the UNITED SQUARE DANCERS OF AMERICA as the "World's largest Square Dance Organization" as a result of their representing over 100,000 dancers.**

- 18 Aug 82** Joe Vaccari (FL), Chairman of the Postage Stamp Commit-tee, submitted four different designs for a commemorative square dance postage stamp to the Citizens Stamp Advisory Committee with information copies to the Postmaster General and Congressman Earl Hutto, 1st District, FL, who supported the effort.
- 12 Oct 82** Organizational Survey conducted by USDA to determine the magnitude of the organized square dance movement. Regional Vice Presidents sent the forms out to dance organizations in their regions.
- 1 Jan 83** USDA National Dancer's Accident/Liability Insurance Program commences with Charles Naddeo (CA) as the Program Chairman.
- 29 Jan 83** USDA Winter Meeting, New Orleans, LA, Travelodge.
- USDA is beginning to receive some coverage in national publications and will be listed in the National Square Dance Directory.**
- Motion made and approved that a CPA audit be waived in favor of an internal audit and that this audit report be made a part of the permanent records.**
- Motion made and approved that in view of the fact that the treasury has very little money, bonding of the Treasurer be waived until a later date.**
- Only state to sign up for the new USDA Insurance Program is California to date. Have had many inquiries from non-affiliates about the insurance program. The Insurance Chairman was instructed to negotiate with the insurance company to include non-affiliates.**
- Joe Vaccari (FL), Chairman of the USDA Postal Stamp Committee advised that the Postal Advisory Committee receives about 5,000 requests a year for commemorative postage stamps and issue about 18 stamps. The Postal Advisory Committee keeps referring to the 1978 folk dance stamp.**
- George Garland (NC) outlined his ideas on a proposed square dance museum and hall of fame. He envisioned this as a place where square dance documents, mementos, etc. could be preserved. In addition to the museum, he proposed a recreational vehicle park for visitors. He had located a suitable site in Macon County, NC that was available for \$100,000 with 25% down and the balance in five years with an option to buy adjoining**

land. Motion made and approved to present a resolution to the Board of Directors that USDA create a museum and hall of fame.

Jim & Jan Maczko (CA), USDA President reported that efforts are being made to establish lines of communications and cooperation with existing organizations, e.g. CALLERLAB, LEGACY, NEC, ROUNDALAB, etc.

Motion made and approved that the Regional Vice Presidents be permitted to set up a regional board to help with organization.

A sample USDA dangle badge, offered by Walter Stoltz (FL), to hang from other badges was approved and authorization for purchase of 1,000 was given.

USDA will have a display in the Showcase of Ideas at the National this year.

A discussion was held on the request from Corinna Roth Studios for support in connection with a limited edition of a Presidential porcelain in honor of the proclamation of square dancing as our national dance.

28 square dance organizations responded to date of the USDA organizational survey.

Charles Naddeo (CA) will investigate the possibility of getting hot-stamp badges for sale as an additional source of revenue for USDA.

It was determined that it was not feasible for USDA to have a publication at this time.

USDA Annual Meeting, Executive West, Louisville, KY.

George Garland (NC), Chairman of the Museum and Hall of Fame Committee, reported that the museum should be located where square dancing got its start. Franklin, NC has been selected where there is a tract of 50 acres available for \$200,000. He envisioned that the museum would serve as a place that square dance material could be sent, catalogued and preserved for posterity. He also proposed having an RV camping facility, which would generate income. 1,000 museum dangles were distributed at the USDA Meeting for sale at \$1.00 each. Another 1,000 will be ordered by Walter Stoltz (FL).

**Joe Vaccari (FL), Chairman of the Postage Stamp Committee, reported that four different designs for a commemorative postage stamp were submitted on 18 Aug. 1982 to the Citizens Stamp Advisory Committee. The proposed stamps were designed by Jack Lorusso, a renowned Florida artist. These designs have been considered by the Citizens Advisory Committee at four meetings without favorable action. Correspondence from the Assistant Postmaster General indicates that the 1983 stamp program has been completed and any favorable action could not result in a stamp until 1984 or later. A block of four stamps were issued in 1978 depicting the different forms of dance (including square dance).**

**USDA passed a resolution urging the Postal Service to issue, as soon as possible, a Square Dancing Commemorative Stamp.**

**USDA represents 132,300 dancers and remains the "Largest Square Dance organization in the world".**

**Charles Naddeo (CA), USDA Insurance Chairman, reported that the first year of the Insurance Program was a success. We have earned \$120.36 in interest and added to the administrative fee of \$.05 per member totals \$943.65. Two underwriters submitted proposals for the 1994 insurance program - R.F. Lyons and Rhulen Agency. R.F. Lyons' proposal was accepted at the premium rate of \$1.00 per dancer.**

**USDA President advised that since no interest has been shown to date, the Executive Committee had decided to table the question of Regional Festivals until there is sufficient interest to bring it forth again.**

**USDA Organizational Survey conducted in 1982 revealed that the average club size is 75 dancers.**

**USDA President invited Corinna Roth, a Pennsylvania sculptress to make her presentation. She showed a limited edition porcelain sculpture "Ancestral Grace", a portrayal of a couple performing a folk dance. She hopes to present this sculpture to President Reagan at such time as the square dance is permanently proclaimed the national folk dance of the US. To show authenticity of her work, her models, Bill & Pat Johnson were present. Ms. Roth proposed a relationship between the USDA and her corporation whereby a percentage of sales would be donated to the fund for the Square Dancers Museum.**

**Betty Coates (CA) suggested that USDA develop a bumper sticker as a fund raiser.**

**Ways & Means Committee established consisting of Mac & Mary McClure (CA) as Chairman, Walter & Esther Stoltz (FL) and Ed & Mary Barbee (TX).**

First USDA Educational Document prepared by Jim & Peggy Segraves (AL) and consisted of a one-page information sheet entitled "Club Leadership". Another USDA information sheet entitled "Club Check List" was developed and used in an educational panel at the NSDC by Jim & Peggy Segraves (AL).

"USDA" a traveling Square Dance Doll was born and started on her nation-wide travel. The USDA doll will be passed from club to club and return for each national convention.

Mac McClure (CA), Folk Dance Committee Chairman, advised that on June 10, 1983 a bill was introduced by Senator Robert S. Byrd of WV, with 27 co-sponsors, to designate the Square Dance as the National Folk Dance of the USA.

USDA President advised that USDA is still not incorporated but it is a project that we will continue to pursue. Jim Maczko will look into incorporation of USDA.

It is hoped to sell badges as a means of generating funds. Once an economical means of producing the badges is found, it is hoped to provide the delegate of each member organization with a badge.

A dress has not been designed as yet but suggestions were requested.

Resolutions adopted: Commemorative Postage Stamp; Support of the National Square Dance Executive Committee; Liaison relationship with Corinna Roth Studio, Inc.. Resolutions presented at previous meetings supportive of the National Folk Dance, Square Dancers of America Float effort, the National Convention, as well as a resolution encouraging cooperation among square dance organizations were re-affirmed.

- 27 Jul 83 Requested one Showcase of Ideas Display Table be reserved for USDA at the 33rd NSDC in Baltimore, MD.
- 27 Jul 83 Letter sent to the Postal Service requesting current status of the proposal for a Commemorative Postage Stamp submitted on 19 Aug 82.
- Jul 83 First USDA Press Release. Developed by Jim & Jan Maczko (CA), Director of Information.
- 14 Aug 83 West Virginia voted to affiliate with the USDA and submits Application for Affiliation.
- 15 Aug 83 Letter sent to Ken & Carla Parker, Chairman, National Executive Committee advises that during the June USDA meeting held in Louisville, KY several discussions greatly influenced the future plans of USDA.

**Regional USDA Festivals:** It has been decided to shelve the plan to sponsoring an annual festival in each of the four USDA Regions so as not to conflict or possibly detract from the National Convention.

**USDA Annual Meetings:** USDA will hold two-hour meetings in lieu of four-hour meetings to assure that attendees would be absent from the National Convention for a minimum period of time. USDA has decided to hold its meeting on Wednesday prior to the convention and hold a short Introduction to USDA meeting on Friday afternoon.

**USDA Participation At The NSDC:** The USDA does not desire to conflict with the purpose, conduct or control of the NSDC, however, we do desire to participate as a recognized National Organization in the same manner that other recognized top national organizations participate. With the same recognition as the other organizations, USDA would become a part of the NSDC and therefore could not compete with it in any manner.

Requested NEC to respond to the desires and affiliation of the USDA and the NSDC. "United We Stand" - for a better square dance movement.

- 20 Aug 83 Frank B. Thomas, Philatelic Programs Specialist, Stamps Div., US Postal Service, Washington, DC advises USDA - The Citizens' Stamp Advisory Committee already has considered the proposal without recommending issuance of a stamp. Since it is the Committee's policy to reconsider a subject whenever there is a new expression of interest, the USDA letter will serve to place the proposal on the Committee's agenda for reconsideration at its next meeting.
- 24 Aug 83 Draft USDA Bumper Sticker designed.
- 18 Sep 83 Charles Naddeo (CA), USDA Insurance Chairman reported that he is meeting with Insurance specialists this month to develop and overall Insurance Program that would be available to members of USDA from which USDA would derive revenue. This would be a program that could include car and RV insurance, health, over and under age supplementary insurance (medical). Direction from the Executive Board will be required.
- 20 Sep 83 U.S. Senate unanimously approved Bill S. 1448 which would permanently establish the Square Dance as the official dance of the United States. The only hurdle ahead now is the House of Representatives, where H.R. 1706, an exact replica of the Senate legislation, now has more than 225 cosponsors. This Bill is being considered by the House of Representatives Subcommittee on Census and Population.
- 4 Oct 83 Congressman Norman Y. Mineta advises the Hon. Katie Hall, Subcommittee on Census and Population, Committee on the Post Office and Civil Service, that H.R. 1706, a bill to designate the square dance as the national folk dance of the US now has 225 cosponsors. Since this number exceeds the cotes 218 cosponsors, I hope that the Subcommittee on Census and Population can begin immediately to consider this important legislation. A copy of the Senate version of the bill, S. 1448 was attached and had passed unanimously last month.
- 1 Nov 83 USDA President Joe & Joy Vaccari (FL) reports of a meeting with Mac MacKenzie (FL) and Frank Cherry (FL), Pensacola Special Steppers and they will submit a written proposal to establish a "Committee on Disabled Dancers" for consideration by the Executive Committee at the USDA Winter Meeting.

- 25 Nov 83**      **Mac Mackenzie (FL) and Frank Cherry (FL) submit a proposal to USDA for establishment of a Committee on Disabled Dancers (CODD) in USDA.**
- 28 Nov 83**      **USDA President Joe & Joy Vaccari (FL) sends letters to non-member organizations and extends an invitation for them to affiliate with USDA. USDA has 15 member organizations representing 16 states with over 150,000 dancers and has become the "World's largest Square Dance Organization". USDA is the National Square Dancers organization, organized by dancers, for dancers, and under the control of dancers.**
- 28 Nov 83**      **USDA President Joe & Joy Vaccari (FL) sends letters to all Affiliate members and relates the USDA programs and projects underway to include:**
- Establish lines of communication and cooperation with other national organizations on behalf of the square dancer.**
  - Strive for unification of dancers through member-ship in the USDA.**
  - Be available to provide assistance to those desiring to organize for the betterment of the square dance activity when requested.**

**USDA Winter Meeting, Dillard, GA - Best Western Motel.**

**First USDA banners produced by Jim & Peggy Seagraves (AL), were distributed to the attendees. A total of 62 banners were provided to USDA for \$150, if and when USDA has money to pay for them out of the treasury.**

**Use of USDA Bumper Stickers and USDA Decals were discussed as fund raisers to obtain funding for a proposed USDA Square Dance Museum. Mac McClure (CA) will request \$4,000 from the California Square Dance Council to get started on this project. (Interest-free loan of \$3,512 was received from the California SD Council)**

**Mac McClure (CA), Chairman of the California Folk Dance Committee reported that they have 253 co-sponsors for a permanent designation of the Square Dance as the National Folk Dance. The California Folk Dance Committee is not a committee of the USDA but has been in operation for many years prior to USDA. USDA does support the California Folk Dance Committee.**

**Malcom MacKenzie (FL), President of the Pensacola Special Steppers, Inc, and Caller Frank Cherry of Florida presented a proposal for establishment of a committee to assist in the coordination activities of handicapped dancers. Walter Stoltz (FL), USDA Historian, made a motion to form a USDA Committee for Handicapped Dancers, seconded by Claude Potter (CO), motion passed. President Joe Vaccari (FL) appointed Mac MacKenzie (FL) and Frank Cherry (FL) as Co-Chairmen of the Committee on Disabled Dancers (Codd).**

**Jim Maczko (CA) was requested to develop a Code of Ethics for presentation to the USDA Board of Directors in June 1984.**

**Joe Vaccari (FL), Chairman of the USDA Postage Stamp Committee reported that the postage stamp has been in the works for 1 to 1 1/2 years. No action has been taken by the Postal Advisory Committee because we do not have the Square Dance as the National Folk Dance. No action is being taken at this time until we see how the National Folk Dance Campaign turns out.**

**West Virginia application for affiliation was approved.**

**Jim Maczko (CA) reported that he has enlisted some qualified assistance to obtain Incorporation and Tax Exempt Status.**

**Letters have been sent to LEGACY, CALLERLAB, ROUNDALAB, National Square Dance Suppliers, National Executive Committee, inviting them to attend our Baltimore annual meeting and give a brief report on their organization.**

Nine USDA resolutions have been passed since its inception: #1. Establishment of USDA, #2. Support the National Folk Dance Committee, #3. Support the Rose Parade Float, #4. Establish a program to form a Square Dance Museum and Hall of Fame, #5. Encourage cooperation between National Square Dance Organizations, #6. Support the Annual National Square Dance Convention, #7. Commemorative Postage Stamp, #8. Support the National Executive Committee in promoting the National Conventions, #9. Establish a liaison with the Corina Roth Studios.

USDA support of Corina Roth Studios was withdrawn and she was informed that the name of the USDA was not to be used in any advertisement she used. (Studio legal problems)

Purchase of 1000 Museum dangles was approved. Nan Habe-rsberger (FL) appointed as Badge Chairman for Director's Badges.

USDA outstanding liabilities amounts to about \$4,000 since 1981. Funds provided by Executive Committee members. USDA paid 10% of the liabilities. USDA is on a "pay as we go" at this time.

Mary Barbee (TX) advised that they had written another letter to Washington on Nov. 16th about the USDA logo and mentioned that they have been in possession of our check for over 16 months. No response from the Government. She heard through the grapevine that the Government was 3 1/2 to 4 years behind.

- 31 Jan 84 Mac MacKenzie (FL) and Frank Cherry (FL) suggested a change in the title for the Committee on Disabled Dancers to "Committee for Handicapable Dancers". Approved.

- 1 Mar 84 USDA President's Report advises of an article in the National Squares Magazines whereby the NEC has publicly taken the position that a National Dancers Association is not only unnecessary but may even be harmful as inferred by the "big brother" statement.
- California Council has approved an interest free loan to initiate the USDA "Decal" program.
- 17 Mar 84 USDA President Joe & Joy Vaccari (FL) submits a letter to the NEC Chairman in response to the article printed in the Feb 84 National Squares. The two page letter takes great exception to the contents of the article and respectfully requests that an unbiased, thorough, fair and favorable consideration be given to the USDA request of 15 Aug 1983 and an early response be provided.

- 1 Apr 84**            **USDA President Joe & Joy Vaccari (FL) requests status of the Commemorative Postage Stamp from Congressman William Ford, Chairman of the Post Office & Civil Service Committee. Status was also requested by separate letter to Congresswoman Katie Hall, Chairwoman of the Subcommittee on Census & Population.**
- 2 Apr 84**            **USDA Treasurer Ed & Mary Barbee (TX) advised that they have heard nothing from Washington concerning the registration of the USDA Logo. Understand that they are 3 1/2 to 4 years behind in review of logos.**

- 11 Apr 84**           **Congressman William D. Ford, House of Representatives, advises USDA of three major concerns expressed about designating the square dance (or any other dance) as this country's official dance. They are as follows:**
- 1. the possibility of offending those who do not feel themselves to be a part of the America that is represented by square dance;**
  - 2. the possibility of creating a perceived standard form of folk dance that will inhibit the natural, creative evolution of American dance traditions; and**
  - 3. the possibility of setting up barriers to our ability to represent the cultural diversity of America to audiences overseas.**
- "While I certainly understand your love of the square dance, I am reluctant to endorse an effort to impose any dance as THE dance of the United States on a permanent basis. However I encourage you and your members to continue to seek the passage of annual resolutions designating certain periods to recognize the square dance."**

- 25 May 84**            **Chairman Ken & Carla Parker of the National Executive Committee of the NSDC invited USDA to a meeting to be held Wednesday evening at the June NSDC to come and explain USDA's proposed assistance to the production of the NSDC.**
- 30 May 84**            **Ruth & Walter Henderson (PA) resign as USDA Vice President of the Eastern Region due to health problems and personal priorities.**
- 3 Jun 84**             **USDA President Joe & Joy Vaccari (FL) responds to NEC letter of 25 May 84 and advises that USDA welcomes the opportunity to meet with the NEC. Jim Segraves (AL) will also attend the meeting.**
- 3 Jun 84**             **USDA President Joe & Joy Vaccari (FL) submits Testimony of the USDA to be made part of the Hearing on HR 1706 to be held in Washington, D.C. on June 28, 1984.**
- 8 Jun 84**             **Congresswoman Katie Hall, Chairman of Subcommittee on Census and Civil Service advises USDA President Joe & Joy Vaccari (FL) that USDA Testimony of 3 Jun 84 will be included in the record of the Subcommittee hearing on H.R. 1706 on June 28, 1984. (Permanent designation of the Square Dance as the National Folk Dance of the US)**
- 11 Jun 84**            **Representative Earl Hutto was requested by USDA Handicapable Committee Chairman Mac MacKenzie (FL) to attend the 28 Jun 1984 Hearing and present testimony on behalf of the Handicapable Dancers.**

USDA recognized the need for a place within the Square Dance Movement for individual Handicapped and Disabled Dancers and created the Committee for Handicapable Dancers to serve as a forum for the identification of existing clubs and leaders, encouraging an exchange of ideas beneficial to the promotion, preservation, and growth of these special interest groups.**

**Code of Ethics adopted by the USDA. (Resolution)**

**25,000 USDA decals, 4" X 5", were purchased for resale at \$.50 each to the square dance community as a fund raiser. Selling organizations to retain 10% of the funds to defray local expenses. Funds for this program was borrowed from the California State Square Dance Council at no interest.**

**The Museum Committee Chairman Walter Stoltz (FL) reported that we have decided to have a Square Dance Museum to incorporate all of the memorabilia of Square Dancing in one area and to help finance this program we have 2,000 small dangle badges we are selling for \$1.00 each. The site chosen for this museum is in Franklin, NC.**

**1,400 "Member Badges" were purchased at \$1.50 each for resale to any member dancer for \$2.00 each.**

**USDA doll named "Usda" has an official USDA costume dress and 32 other outfits she has accumulated in her travels throughout the USA. Usda will be exhibited on the USDA Display Table.**

**USDA Board of Directors approved the formation of "The Committee for Handicapable Dancers."**

**Insurance Premium Rates with Rhulen Agency for 1985 were announced.**

**2,000 USDA Museum dangles were purchased for resale at \$1.00 each to assist in financing the Museum and Hall of Fame Program.**

**The 1981 request for a Square Dance Commemorative Postage Stamp is on the back burner pending approval of Square Dancing as the National Folk Dance of the USA.**

**The USDA check for Logo Registration has been cashed, but no word from Washington has been received. Apparently the Logo is registered.**

**Approval was obtained to enter into agreements with The Rhulen Agency for the 1985 USDA Insurance Program. R. F. Lyons Co. had the previous USDA Insurance Program.**

**USDA official dress costume presented by Loraine Backus (AR) and approved by the Board of Directors.**

**Status of 1981, 1982, 1983 USDA Resolutions:**

- 1. Establish the United Square Dancers of America.**
- 2. Supporting the Square Dance as the National Folk Dance.**



3. Support the Square Dancers of America Rose Bowl Float.
4. Establish an effort to establish a Square Dance Museum and Hall of Fame.

Insurance Chairman Charles Naddeo (CA) reported that if the participation in the program continues to grow, it will be necessary to hire a person for a minimum of one day a week with the option of increasing that during the busy months of January - March, to as many days as may be needed. Mrs. Jan Wells, Assistant Ins. Chairman for California Square Dance Council, has tentatively agreed to put the insurance records on computer discs.

Insurance premiums increased to \$1.15 for Affiliates and \$1.45 for Non-Affiliate Associations and \$1.65 for Non-Affiliate Clubs.

Handicapable Resolution was approved. USDA will take every possible action to encourage the establishment of Square Dance Clubs for the Handicapable in their communities by contacting organizations serving the Handicapped/Disabled, providing Angel Helpers, and soliciting cooperation and support from local Square Dance Callers.

Large USDA Banners, 24" X 36", cost \$9.50 and small banners, 8.5" X 11", cost \$2.50. USDA purchased 24 large banners and 100 small banners. Small banners will be presented to USDA Affiliates by the Regional Vice Presidents at no cost. USDA lined jackets cost \$25.00.

3,000 small U.S. Flags, stick-ons, are available to hand out to attendees of the USDA After Party.

USDA is continuing to consider conducting Regional Festivals without conflicting with the National Square Dance Convention. The Regional Festivals would be conducted in all three USDA Regions each year with no Festival in the Region that has the National Convention. A motion was approved to prepare guidelines for conducting Regional Festivals. Regional Festivals will be fund raisers for USDA and the sponsoring organization. Amarillo, TX has offered its facility at no cost to USDA.

The National Executive Committee (NEC) has still not responded to USDA proposal to participate in the National Conventions.

National Folk Dance Committee reported that the NFD Bill died in Committee this year.

**USDA Fiscal Year changed to coincide with the Calendar Year.**

**\$1,000 was allocated to the Handicapable Committee and \$1,000 allocated to the Education Committee for 1988.**

**The Board of Directors approved the Affinity Credit Card concept and authorized the Credit Card Committee to proceed with the program.**

**The Handicapable Committee reported that Co-Chairman Mac MacKenzie (FL) does the administration and correspondence duties and Frank Cherry (FL) works with other callers teaching handicapable dancers.**

**Great national publicity has been received about the USDA Handicapable Program.**

**A metal lapel pin made in the replica of the Square Dance Postage Stamp issued in 1977-1978 was available for sale at the 37th National Square Dance Convention Post Office for \$2.00.**

**Commemorative Postage Stamp program activities are being held in abeyance pending the outcome of the attempt to obtain designation of the Square Dance as the National Folk Dance of the USA. Action will be initiated immediately following designation by Congress.**

**A computer and associated peripheral components were authorized for the Insurance Committee.**

**A copier was purchased for \$1,186.50 by the Insurance Committee.**

**First time a "Handicapable Hall" is provided at a National Square Dance Convention - 37th NSDC - CA.**

**Four Press Releases developed and distributed by Jim Maczko (CA) during the past 12 months concerning: Annual Meeting, Insurance Program, Winter Meeting and Annual Update.**

**The following Handicapable Dancers Resolution adopted:**

**Whereas: The Handicapable Dancers are an integral and important part of the Square Dance activity and should be recognized for their inspiring participation,**

**Whereas: For the first time in the history of the National Square Dance Convention, facilities were made available for Handicapable Dancers by the 37th National Square Dance Convention Committee in Anaheim, California in June 1988,**

**Whereas: The United Square Dancers of America, Inc. wishes to express appreciation on behalf of the Handicapable Dancer for this historical expression of support,**

**Therefore: Be it resolved that letters of appreciation be sent from the President of the United Square Dancers of America, Inc. and from the Co-Chairmen of the USDA's Handicapable Dancers Committee to the 37th National Square Dance Convention Executive Committee.**

**That \$1,000 be authorized for in-house publicity, including ads in selected State/major association S/D Publications and other publicity. These funds are to be used only if the bank doesn't pay for this publicity.**

**The Mastercard Application Form for 1989 stated the card could not be offered in Wisconsin and Iowa. This was noted in the press release dated September 1989. Due to late notification, it is recommended that Iowa's share be granted for 1989.**

**The 1990 Mastercard Application Form for 1990 will state the card offer is void in Colorado, Iowa, Maine, North Carolina and Wisconsin (Due to restrictive State Laws).**

**Walt & Sally Baechle (NY), Ways & Means Committee Chairman, reviewed previous records and reported that as of June 1987 there were about 11,400 USDA Decals on hand. Of these, 4,900 were sent to organizations on consignment. Records reflect that there wasn't any acknowledgement that the decals were received or any payment made for about 3,000 decals. USDA took no action pending completion of the negotiations.

BMI/ASCAP Committee established with Chairman Jim & Peggy Segraves (AL), Jim & Kathy Maczko (CA) and Frank & Nan Habersberger (FL). The Committee is to attempt to obtain a blanket licensing agreement between BMI, ASCAP and Square Dance Clubs.

**FINANCIAL GUIDANCE:** This is NOT offering them money but is providing information regarding possible fund raising projects and events.

**DIRECTORY:** Develop a directory to include name of club or organization, location, dance night, time, age group and name and address of contact.

**Letter from USDA Attorney James Hyden (AR) states that USDA enjoys a "public charity" status since its sources of income are from the general public as opposed to a "private foundation" which receives its income from a few sources. As such, a public charity qualifies for full charitable deduction privileges by donors. The proposed Youth Program appears to be consistent with the purposes under which USDA was formed and is currently operating. There is no need to set up another organization or trust fund. Solicitations by USDA are permissible activities. Donations to USDA are tax deductible. The objectives of the Youth Advisory Committee can be met simply by establishing a dedicated or segregated account under USDA's employer identification number just as USDA has done with the separate insurance account. Accordingly, the USDA leadership would exercise ultimate authority over the expenditure of these funds, perhaps guided by the recommendations and requests of the Youth Advisory Committee.**

Recently the courts have ruled in favor of both sides making the decisions arbitrary and subject to the whims of the judges.**

**Education Committee is maintaining 23 USDA Information Sheets, 6 Pamphlets and 3 Booklets.**

**One gross of USDA T-Shirts ordered for resale.**

**Georgia became State #29 to have the square dance designated as their official State Folk Dance. Connecticut and South Dakota have joined the ranks.**

**During the period of July 1, 1995 to April 9, 1996, 6,032 educational trifold, 513 pamphlets and 388 booklets have been requested from the USDA Education Committee.**

**Eight display tables were requested for the USDA Showcase of Ideas display at the National Convention.**

  - b. Youth - Tolerance toward teaching and dancing with younger dancers.**
  - c. Seniors - Tolerance toward teaching and dancing with older dancers.**
  - d. Encourage family groups in classes and clubs.**
  - e. Encourage single dancers in square dance classes and clubs.**
  - f. Tolerance for all ethnic groups. (USDA - Concur but change "tolerance" to "acceptance".**
- 7. Develop programs for square dancing in public schools, as well as colleges and universities. Encourage square dancing as part of required curriculum and for teacher accreditation, so that teachers can teach square dancing in schools. (USDA - Refer back to callers)**
- 8. Support one charity nationwide to obtain national publicity for square dancing. (USDA - Delete this goal. Opposed to one charity.)**
- 9. Re-evaluate current dress guidelines, and seek acceptance of alternative, yet appropriate styles. (USDA - Still re-evaluating.)**

Credit Card ad placed in American Square Dance Magazine of the months of September, October, November, 1996 and January 1997 at a cost of \$368. An ad was placed in the 1997 National Square Dance Directory at a cost of \$90.

Education Committee reported 3,115 trifolds, 377 pam-phlets and 307 booklets were mailed out in the last six months of 1996.

Review by Jim Segraves (AL), USDA Director of Information, of the publication by Ken I about standardized calls for wheelchair dancing suggested three options for USDA. 1. Start gathering "Wheelchair Dancing" material and write our own USDA Booklet; 2. Get Ken I to work with USDA in the development of a new Booklet; 3. If agreeable to Ken I, Vancouver, B.C., use his data in a new USDA Booklet and give him credit and appreciation for most of the contents of the Booklet. He gets no money, just publicity and promotion. The Executive Committee approved the first option - USDA to develop our own Booklet. The Education Chairman John & Janet Rothrock were directed to head up a Committee to gather the data and write the USDA "Wheelchair Dancing" Booklet with assistance of the Handicapable Committee and the Director of Information.

**The USDA Historian, Gailard & Jo Ann Janes (CO) are working on the USDA display that will depict photographs of the USDA Officers and Committee Chairmen. The display will be used at the National Conventions in the Showcase of Ideas.**

**A copy of all USDA general correspondence should be submitted to the USDA Secretary for file.**

**3,590+ copies of the USDA News were mailed out in 1996. There are 299 paid subscribers.**

**Jim & Edythe Weber, USDA Publications Committee Chairman reported that the "on-line" efforts of USDA have been well accepted. The "Web Counter" indicated that 699 persons have accessed the Home Page of USDA NEWS on the Internet since July 26, 1996. This count does not duplicate, surfers are only counted once. He expressed his desire to make the Square Dance as the National Folk Dance, purchase a considerable number of USDA Newsletters to send out with his video tapes and to purchase ads in the newsletter on a continuing basis. He made a tape with the Executive Committee singing "Dancin in Branson", issued each member T-Shirts and ball caps with the Dancin in Branson logo. Because everything had been verbal, it was decided to request Mr. Ganaway to put his proposal in writing for consideration by USDA. Mark Mortensen (MO) was requested to contact Mr. Ganaway and request his proposal and plans be put in writing to the USDA.**
