

2020 - A MOST UNUSUAL YEAR!

2020! A year that will remain in the corner of my mind for the rest of my life and I would be willing to bet that you can say the same.

I remember it well. For me it was a delightful afternoon in March; Friday, March 13th to be exact, and I was getting my monthly Macular Degeneration injections, one in each eyeball. As the Dr. completed his procedure he turned to me and asked how I was preparing for this invasion of the new flu virus. The WHAT?????? I had to admit that I had heard a little about some virus, but I was not prepared for an intellectual discussion with this man that was obviously well versed on the subject. As I left his office that afternoon I felt much better prepared to discuss the Corona Virus with anyone. I now understood the difference in a Corona Virus and a Corona beer. When I left my Dr.'s office that afternoon I had a much better understanding of "high risk patient" "quarantine" and "isolation".

As we left the Dr.'s we discussed the situation and how we would handle things on our end. Since my food pantry usually ran 24% or less a stop by the food market seemed in order. Growing up on small farms in E. T. we never ran short of food in the 1960's, so many of the Bible stories were pretty vague to young teenage boys with plenty.. We grew our own food. For the first time in my life I walked into a supermarket to find bare shelves. The television stories were obviously true. There were no paper towels, toilet paper, napkins or any other type of product that came close to representing a paper product in any form or fashion. Neither were there any bananas, or other fruits, vegetables or anything else I would consider putting in my mouth. Remembering now that I did have a few cans of soup in the cupboard I felt I could make it through the summer, after all, this will pass quickly.

For the next 4-5 months no one came in or out of my house. I learned the meaning of quarantine back in March, remember? But then things begin to change. Things are going back to normal. Shorter store hours, limited occupancy, customers wear face mask. I have watched people come and go long enough so if I follow the guidelines I should be OK. What I found was no one was following any guidelines. I tried, but not hard enough. The stores were crowded, customers and employees alike were not wearing mask.

In the late afternoon on Nov..19th I was in my bed, sleeping comfortably when I heard my name being called by an unfamiliar voices. My granddaughter had tried to reach me, but I had not responded and she called 911. When I asked what was going on I was informed that I was very sick and they were taking me to the hospital. I had COVID-19. As many times that I had shuddered at the sound of that word, tonight I simply closed my eyes and said "OK".

After two days in ICU it was determined that it was not 'COVID', however it was diagnosed as Influenza Type B and was transferred to "Intermediate Management Unit" for two weeks. There I was allowed one daily visitor and only the same one each day. My son Chris (our USDA NEWS cover designer) stayed with me. I am now in "Extended Care" with NO visitors allowed.

THANK YOU FOR ALL THE PRAYERS AND GOOD WISHES.

I realize there are many others with much worse conditions than I and I send prayers to them and their families as they experience one of the most unusual years we have ever known.

EVENTS IN THE WESTERN REGION

As with much of the country, there is very little dancing going on in the Western Region. Most of our states have restrictions on social gatherings as well as travel. As a result, we have not done any travel or dancing since spring, beyond a few sessions in our family room via Zoom. We have updated our contact list for the Western Region affiliates and sent e-mail communications promoting the USDA "Beyond the Dance Floor" webinar series. We were pleased to see a number of Western region organization leaders participating in the November webinar on the USDA 501(c)(3) Group Exemption Program. We have already heard of several clubs and local associations that are interesting in applying for the program.

There is a lot of discussion about what to do to get experienced dancers back, and new dancers into lessons, once the coronavirus restrictions begin to lift. One option being explored and promoted to revitalize square dancing is the Social Square Dance or Sustainable Square Dancing (SSD) program. This is a program of 50 calls that can be taught in about 12 weeks. It is intended to attract new dancers and get them dancing successfully and, most of all, having fun. The program could also serve as a way to reintroduce experienced dancers who have been "off the floor" for many months. Per a CALLERLAB press release, "The CALLERLAB Board of Governors endorses the use of SSD as one approach for getting current dancers back on the floor having a fun and enjoyable time, as well as being a fast paced approach for bringing new people into our Square Dance community. This would include the prospect of having a well thought out plan in place for multiple lesson starts, thus providing a path to re-energize Square Dancing as we emerge from the Covid-19 crisis.

USDA INSURANCE COORDINATORS NOTES

Greeting Everyone,

By the time you receive your Jan-Mar issue of the USDA News, we will be in another year. The holidays will be behind us and hopefully we will be looking at starting back to dancing.

In my last article I reported that we had not received the 2021 rate from RPS Bollinger. We have now received that information. The rates for 2021 will be the same as the rates for 2020. The insurance coordinators have received information about this.

The insurance portal had encountered several problems (it must have been infected with some kind of virus) but as of today it is working again. You can now enter your information for 2021 in the portal.

I am including below information that I had in the Jul-Aug edition and the Oct-Dec edition (with updates). It's all good information that needs to be repeated.

Questions referring to the pandemic:

- **Mainstream Classes:** The insurance company will allow for a break in the nine (9) month coverage for students. You must keep a record of the start date, temporary stop date, date you start again and date you graduate the students. If you choose to begin the class from the beginning when we do go back to dancing, then you will treat it as a new class. You will need to submit the names again.
- **The COVID-19 is a virus and is not covered by our Accidental Benefit portion of the insurance policy.** Our policy covers accidents, not the flu or any other viruses. There is liability coverage for the club.
- **Rates and Deadlines for 2021:** The ideal deadline (for the insurance coordinators) is to have all your clubs' rosters and facility information in the insurance portal by December 31, 2020. You should have your fees for insurance submitted to me by January 20, 2021.

USDA Insurance Information

1. Will our insurance cover dancers who have contracted the COVID-19 virus?

No. Our insurance is for medical benefits associated with an accident at any regularly scheduled and sponsored activity. The USDA insurance has never covered any type of virus.

2. If our state has said no public gatherings will our insurance cover our dances?

No. If your state says no public gatherings and your club meets then the law has been broken and there is no coverage.

If your state is opened up for public gatherings and allowing groups to gather and the clubs are following CDC guidelines, then your club would be covered.

3. If someone sues?

When a dancer sues the club and/or club officers, that dancer will have to complete a claim. The claim will be submitted to the insurance company. The insurance company will then be in charge of the claim. **NO LONGER** will the club have any involvement with the lawsuit. The insurance company and their team of lawyers will handle it.

4. Are visitors insured?

Yes and No. If the visitor is a member of another club which is a member of the USDA Insurance program the answer is Yes. If the visitor is not a member of any club or is a member of a club that does not participate in the USDA Insurance program the answer is No. The club should still complete an accident form and keep it on file.

5. Are Students covered by our insurance?

Students are covered for nine months of instruction. After nine (9) months they are no longer insured. When they join the club the insurance fee must be submitted to your insurance chairperson. The rate is not prorated. If they join in December then they still pay the full amount.

NOTE: Due to the COVID-19 virus the insurance company will acknowledge that there is a break in the 9-month instruction period. The total combined number of weeks of instruction should not exceed 9 months.

6. Accident Claims:

Please have accident forms at all dances. Complete the form for all accidents and submit to your insurance chairperson. Complete the accident form on all dancers whether they are a member of your club or not.

7. Insurance Portal:

Each affiliate must decide how they want the club's information entered in the insurance portal. (1) The clubs can enter all information and submit the enrollment fee plus the club's roster to the affiliate insurance coordinator. OR (2) The clubs can send all enrollment forms plus enrollment fee (this is the same way it was done before the insurance portal) to the affiliate insurance coordinator, then the insurance coordinator would enter all information for all the clubs in the insurance portal.

Walter and Jane started their basic level class with Somerset Hills Square Dance Club. After graduating basic level, they moved on to advanced level with Valley Squares. They remained with Valley Squares for many years. Walter also served as President of the Valley Squares for many years. After Valley Squares folded they moved to J & M Squares, a higher level club.

Should you ever find yourself with Walter and the conversation begins to drag, just ask him if he ever square danced. Don't ask unless you have time to listen. He would love to tell you all about it. Topping his list would be: **The people.** Everyone was so nice and all loved to dance. They met and became friends with so many square dancers.

***The Raids:** Square Dance Couples would raid another club's dance. Again many friends were made at the raids and this gave you an opportunity to dance with them. After the dance they went out for Pizza and Beer with members of the various clubs. They enjoyed the fun of going into a restaurant in their colorful Square Dance attire.

After Jane passed away in 2003 Walter periodically went to various dances. Almost 10 years later Walter was attending a performance and the MPAC when Cathy, one of his old square dance friends recognized him. She lost her husband several years earlier. Today, Cathy and Walter met for lunch every so often.

Constance A. "Connie" (Jacquel) Houle, 76, of Westfield, was Called Safely Home on Thursday, November 19, 2020. She passed into Eternal Life at home surrounded by her loving family.

Connie was born in King City, CA on March 14, 1944, a beloved daughter of the late Serge E. and Jeanne A. (Laramée) Jacquel. She was

raised in the Aldenville section of Chicopee, graduated from Precious Blood High School in Holyoke and lived in Chicopee until moving to Westfield in 2003. She worked as a Home Health Aide for Home Staff Health Services and was also a cook at Kirby Junior High School.

Connie was an accomplished Square and Round Dancer. Along with her husband, Lenny, they dedicated their social lives to square dance activities throughout the country where they've received numerous awards and recognitions. Among the highlights were serving as the 1996-98 President of ED-SARDA, 1995 VP of the SDFNE, 1998 Induction into the Square Dance Hall of Fame, and 1998-2020 Secretary of NE Co-op. They served as President of the United Square Dancers of America (USDA) in 2008-2009. In 2013 they joined the Board of Directors for the National Executive Committee, and served as General Chairmen of the National Square Dance Convention in Springfield, MA in 2015. In 2014 they received the Pinnacle Award for outstanding leadership, professionalism and dedication to Square and Round dance activity, presented by NE Callers School.

She also enjoyed camping, cruising, traveling, and most especially spending time playing cards with her family and friends. Connie leaves her beloved husband and best friend, Leonard A. Houle. They were married on November 28, 1963 at Sainte Rose de Lima Church in Chicopee and were blessed with over 56 years of happiness together. She also leaves her four loving children, Thomas L. Houle of Chicopee, Timothy A. Houle of Belmont, MA, Karen M. Boisjolie of Chicopee and Jennifer L. Hale of Westfield; her three cherished grandchildren; her cherished great-grandson, and several other family members and close friends.

In addition to her parents, she was predeceased by her two brothers-in-law, Gerald "Jerry" Houle and his wife, Marlene, and Roger "Raymond" Houle; and her sister-in-law, Lorraine Bouchard and her hus-

A devout member of Watchung Presbyterian Church, Shirley served in multiple capacities, including her beloved bell choir. She was a tireless Girl Scout and Cub Scout leader. Shirley enjoyed vacationing on Lake Winnepesaukee, gardening, and sewing.

Shirley and Dick square danced in all 50 states, performed in the nationally televised 1986 Liberty Weekend, headed the Northern New Jersey Square Dance Association, attended 22 National Conventions, received the 2013 Yankee Clipper award, and helped organize the 2015 National Square Dance Convention. Together with her husband, Dick, they served as Eastern Region Vice Presidents for the United Square Dancers of America (USDA).

In 1994, they "retired" to Jaffrey, to be closer to their granddaughter, Meghan (Griffith) Ferrari, now of Canton, NC. Membership in Union Congregational Church of Peterborough inevitably included more leadership roles. The pair moved to RiverMead in Peterborough in 2013, where they made many friends.

To register for housing online, go to 70nsdc.com and click on housing: hotels, camping and travel on the left side of the site. After May 15, rooms will not be discounted and may not be available depending on hotel occupancy.





HISTORY OF THE WESTERN TWIRLERS SQUARE DANCE CLUB

Western Twirlers Square Dance Club was established in 1948 in Joplin Missouri. The club belonged to the Tri State Square Dancing Association & Northeast Oklahoma Square Dance Association before Missouri Federation was established in 1959. The club danced at several locations in Joplin before building the Joplin Square Dance Center in the early 80's for all the area clubs to dance at. In 1982 they formed a Board to help work on finding property and raising necessary funds. They purchased land December 6, 1983 for \$2,700. In 1985 construction started. The cost was \$30,000.00 for 100 Ft X 50 Ft. building. Due to the tremendous support of this area, a lot of past dancers volunteered their time to help build this building. A lot of benefits were also held, particularly the memory board. For a small fee, dancers could have their names engraved into it. This board is behind the caller stand in great appreciation of our past. A Grand Opening dance was held on August 8, 1986, with area callers for an afternoon dance and Virgil Gemeinhart, from Springfield, for the main evening dance. The building was built with a concrete floor with tile to dance on. In 1997 a new wood floor was added with a cost of \$25,000. This building can hold 12 squares on the floor comfortably, along with a Caller Stage, full kitchen, large bathrooms, and tables for socializing.



For a small fee, dancers could have their names engraved into it. This board is behind the caller stand in great appreciation of our past. A Grand Opening dance was held on August 8, 1986, with area callers for an afternoon dance and Virgil Gemeinhart, from Springfield, for the main evening dance. The building was built with a concrete floor with tile to dance on. In 1997 a new wood floor was added with a cost of \$25,000. This building can hold 12 squares on the floor comfortably, along with a Caller Stage, full kitchen, large bathrooms, and tables for socializing.

Past Club callers have been Floyd Sill, who called 25 plus years retiring in 1987. Van Greenwood then became Club Caller from 1988 thru 2010. Van called for more than 60 plus years in the four-state area. He and Elfrieda remained members until Van's passing in 2018. Van & Elfrieda always set at the 1st table to greet everyone. Van & Elfrieda, in later years, were members of the Center's Board and Elfrieda still remains, and is still dancing with us today. Also original Board members and present Presidents of the Board are Wayne & Doris Donham. They have danced since 1978. Sadly we lost Wayne in the past year. Wayne & Doris have maintained and cleaned every inch of this building. Wayne will always be there to sweep the floor during the last tip. Van Greenwood's voice will always be heard in this building by us present members.

Western Twirlers has been thru many changes and challenges thru these years. They have changed from dancing every Saturday night to 1st, 3rd & 5th Saturday's, then to 1st & 3rd Saturdays. In 2011 we changed to once a month.

On November 9-10, 1963 the 3rd Annual Missouri Federation Festival was held in Joplin at the famous Connor Hotel (built in 1906 with a grand staircase made of marble) at 4th & Main, and Saturday's evening dance was held at R & S Stadium at 3rd & Virginia. Club caller was Floyd Sill, State Presidents were Ray & Georganna McCulley. This was also the 1st year for the souvenir program books. The dance had live music and included round dancing. In 1967 Western Twirlers Presidents were Conrad & Joyce Butler, club dues to Missouri Federation was \$1.00. In 1968 the State Festival was held again in Joplin at the Memorial Hall. In 1970 John & Karen Eubanks became Secretary of Southwest District Square Dance Association. In 1971 they became Vice President of Southwest District. John Eubanks became a caller about the same time and became Western Twirlers Club caller in 2019. In 1982 Southwest District had 44 clubs. In 1983 Club dues were \$ 3.00, Show-Me Doin's magazine was \$5.00. Missouri ranked 6th in the world in Square Dance Clubs. In 1984 the State Festival had 1,260 registered dancers, making that year the biggest Festival so far. In 1995 membership in Missouri consisted of 132 clubs and the State Festival had 900 dancers. Missouri Governor Mel Carnahan signed a bill to make Square Dancing the Official American Folk Dance of Missouri. (Currently 31 states have designated Square Dancing as their State Folk Dance.) (Remember we danced on a nearly new wood floor!) In 2005 Club Caller Van Greenwood received the Caller/ Cuer Hall of Fame award. In 2010 a Facebook page was set up along with an email address for extra contact information as we move into the Internet world. On May 22, 2011 an F5 Tornado tore thru Joplin's middle section. The Center was not harmed even though several past and present dancers lost their homes. 2019 Southwest District hosted the MO State Festival in Springfield for its 60th anniversary. Club caller was John Eubanks and State Presidents were John & Bev Stuart.



This club and building has hosted many benefit dances, too many to count. Many thanks to those who have passed that started this club, building, and who have been members. Thank you to the original board members of Jerry & Scarlet Upton, Bill & Mary Watson, Cecil & Betty Clevenger, and Wayne & Doris Donham, the Tri State Square Dance Association (that no longer exists) Northeast Oklahoma Square Dance Association, Southwest District, and Missouri Federation of Square & Round Dance Clubs. Thru these 72 years we have gone from a very large club to a small size club. We are still there to socialize with each other, past and future dances. Now in 2020 we have Covid-19 giving us even bigger challenges, since we have not been able to dance in three months.
