## EVENTS IN THE CENTRAL REGION

Lynda and I have very little to report this month but found the following interesting and thought others would enjoy.

A couple of weeks ago, a member of the NC Federation sent out an email to the dancers of his four clubs to report on the activities of the NC Federation virtual meeting that happened on the day originally scheduled for the State Convention. He included a little survey to get a feeling about how everyone is feeling about the near and long term prospects for the resumption of our beloved square dance activity.

His report is below.

*"Happily, the email was forwarded to other clubs and callers in the area and state, so I was able to hear from many other dancers about how they are doing and about how they see the future of square dance in our area.*

*The survey was not intended to be scientifically rigorous. Respondents are self-selected and are mostly from Triangle area clubs. I encouraged comments, which while not easily quantifiable, provide valuable individual insight. I received 37 responses, most representing couples.*

*A small number (16%) want to dance now, while the majority (54%) wait for a safe and effective vaccine, or otherwise indications that all is OK. The government has limits on gatherings, leading to repercussions on venue availability and liability, so the rest (30%) are waiting for permission. In the meantime, many worry about advancing age and declining health. And people have differing comfort levels with protective behaviors/requirements like masks, hand washing, no-touch, etc.*

*It's safe to say that our square dance community will not emerge unscathed from the pandemic. Wow, just a half year ago things were normal, and we were still dancing!"*

# USDA INSURANCE COORDINATORS NOTES

## USDA INSURANCE COORDINATORS NOTES

Greeting Everyone,

As I compose this article today, I am reminded of Hurricane Laura and her destructive path through Louisiana. Having a son that lives just east of the path reminds me of how close these disasters can be even if it is 700 miles away. I continue to pray for my family and friends in Louisiana.

I have updated several forms that are on the USDA website ([www.usda.org](http://www.usda.org)). Please review these forms periodically as I will be making more changes.

Unfortunately, Bollinger has not given us our insurance rate for 2021. As soon as I receive that information, I will be sending emails to all the insurance coordinators. If your organization has changed insurance coordinators, please make sure that I have your updated information. A few affiliates have given me their updated information, just want to make sure that I have everyone's correct information.

I am including below information that I had in the Jul-Aug edition. It's all good information that needs to be repeated.

Questions referring to the pandemic:

**Mainstream Classes:** The insurance company will allow for a break in the nine (9) month coverage for students. You must keep a record of the start date, temporary stop date, date you start again and date you graduate the students. If you choose to begin the class from the beginning when we do go back to dancing, then you will treat it as a new class. You will need to submit the names again.

The COVID-19 is a virus and is not covered by our Accidental Benefit portion of the insurance policy. Our policy covers accidents, not the flu or any other viruses. There is also liability coverage for the club.

**Rates and Deadlines for 2021:** As of June 1, no determination, from the insurance company, has been made for the 2021 Insurance fee. Please begin collecting the information from your clubs. The ideal deadline (for the insurance coordinators) is to have all your clubs' rosters and facility information in the insurance portal by November 15, 2020. You should have your fees for insurance submitted to me by November 30.

## UNITED SQUARE DANCERS OF AMERICA OFFERS NONPROFIT STATUS TO QUALIFYING MEMBER GROUPS



As a result of the Internal Revenue Services' December 2019 recognition of the United Square Dancers of America (USDA) as a Central Organization with the ability to extend 501(c)(3) nonprofit status to its qualifying members, the USDA Board of Directors have amended the USDA Governing documents (Bylaws and Standing Rules) to extend the opportunity for its members to become nonprofit groups.

Those USDA Affiliates and Associate members who choose to apply for 501(c)(3) nonprofit status will be afforded all the benefits of the IRS designation of nonprofit status:

- ❖ This procedure relieves each of the subordinates covered by a group exemption letter from filing its own application for recognition of exemption.
- ❖ Exempt from Federal income tax.
- ❖ Relieved from paying state corporate income, franchise, and excise taxes.
- ❖ Eligible to receive private foundation grants.
- ❖ Potential to be eligible to rent dance facilities below-market rates.
- ❖ Qualified to receive tax deductible bequests, devises, transfers, or gifts.
- ❖ Can offer individual donors and corporate donors a tax deduction for their charitable donations. The possibility of a tax deduction is often an incentive for taxpayers who itemize their income tax deductions.
- ❖ Eligible for lower postal rates on third class bulk mailings through the US Postal Service.
- ❖ Officers and Committee Chairs of the USDA Affiliates are entitled to deduct their out-of-pocket expenses when serving the nonprofit entity. This applies to monetary or in-kind donations to the organization while serving to benefit the USDA Affiliate.
- ❖ Entitled to Public Service Announcements (PSAs) on Radio and Television.
- ❖ This designation is perpetual and needs to simply be renewed annually with the USDA as long as the Affiliate maintains their membership in USDA.
- ❖ Recognition as a 501 (c) (3) organization adds to the organization's legitimacy and makes it more credible in the eyes of the public and other entities.

USDA Affiliates and Associate members may now apply to the United Square Dancers of America for 501(c)(3) nonprofit status by:

- ❖ Confirming their membership agreement to comply with the USDA Code of Ethics and USDA Code of Conduct;
- ❖ Submitting their Application with \$100 Application Fee;
- ❖ Submitting a letter requesting to be included in the USDA Group Exemption Program;
- ❖ Submitting copies of their Governing Documents (Articles of Incorporation, Bylaws, Standing Rules);
- ❖ Establishing their fiscal year to coincide with USDA (January 1<sup>st</sup> to December 31<sup>st</sup>);
- ❖ Provide their Federal Employee Identification number (EIN);
- ❖ Providing a copy of their current IRS declaration letter.

Subsequent to being approved by USDA as a nonprofit organization, each Affiliate / Associate will simply continue to file their required form 990 with the IRS and submit to USDA the listing of their current officers along with a \$50 yearly processing fee and their annual financial reports.

## FEATURE ARTICLE

Edie Hoge was born on July 18, 1920, in Lowell, Montana. Following her high school graduation, she joined the Civil Service near the beginning of World War II, serving 18 months in Anchorage, Alaska, and 18 months in Brazil. During her time in Brazil, she met a handsome Air Force member named Bill Hoge. She wrote a letter to her sister back home in Montana, telling her “I just met the man I am going to marry.” Edie and Bill were married in Tulsa, Oklahoma on September 13, 1946, and made Tulsa their home together until Bill’s death in June, 2009. Edie and Bill were parents to two sons, one of whom passed away shortly after Bill’s death. Edie still lives in Tulsa, and enjoys her 8 grandchildren and several great-grands.



Bill and Edie first took square dance lessons with Swing All 8 square dance club in Tulsa, during the Fall of 1947. They completed their lessons in time to participate in the first NorthEast Oklahoma Square Dance Association Festival in April, 1948, and Edie continues to enjoy the Festival every year. Edie and Bill were charter members of Tulsa Crossfires club, and she continues to dance with Speck-Taculars, where she is a Lifetime member, and with Rushing Stars. Edie still dances in the many colorful dresses and petticoats she has accumulated during her many years as a dancer.

Bill’s employment with American Airlines allowed the Hoge’s to travel extensively, and they took the opportunity to square dance wherever they could. On an around-the world trip, they were part of a group who danced on the Great Wall in China. Edie also recounts dancing at 10,000 feet in a “great big double decker airplane”, after first getting permission from the pilot to do so.

To visit with Edie is to have a ride along on her world travels. She has swum in both the Arctic and Antarctic Oceans, visited the Galapagos Islands, made several trips to Italy, and flew over the Sarengeti in a hot air balloon. A special memory was a trip she and Bill made to Australia and New Zealand during the early 1950s, when she captured a picture of Queen Elizabeth in a car driving in front of the house where they were renting a room.

Edie says she doesn’t like being the center of attention, but to the many dancers throughout NorthEast Oklahoma, she is a very special person who deserves all the attention we can give her!

## PRESIDENTIAL GUIDE TO VIRTUAL DANCING

The last time I engaged in Real Dancing was in March, a few days before Lock-down. Now, feeling decidedly un-match fit, out of condition and struggling to remember what day of the week it is, let alone square dance definitions; I decided to embark on a spot of Virtual Dancing henceforth to be known as V.D.

For your delectation I offer a light-hearted guide for newbie dancers to the V.D. world. Do not assume that V.D. just amounts to showing up, pressing the link, moving the sofa and squaring up. To maximise the benefits of V.D. remember 'Preparation is key'.

1. Allow plenty of time to prepare the dance space. Humping large pieces of furniture around (in my case alone) is no easy matter. It requires skill and energy both of which you will need in spades when the real V.D. starts.
2. Wear suitable footwear. After 20 minutes of shuffling around in fluffy slippers (no, not pink ones on this occasion, but thanks for asking) on carpet is not conducive to good body flow.
3. Allow yourself time for a pre-V.D. lie-down, your body will have forgotten just how tiring dancing is.
4. Make sure that snacks and beverages are readily accessible.
5. Dancing indoors is preferable to outdoors. On one occasion, on a particularly hot and humid night I danced on my patio having flung open, yes with gay abandon, my French doors. All was going so well, I had even chalked out the position of the dancers and the flagpole, when a succession of emergency vehicles were heard driving like 'The Dukes of Hazzard' along the nearby main road. As night fell the bats were out and about. But what finally drove me indoors was after a spectacular display of 'Donner and Blitzen' there followed a sudden heavy downpour. I quickly retreated inside. Couldn't go out again – it had washed away my chalk marks !!!

I would recommend all dancers to give it as go; you don't have to dance, it is just as interesting and useful to sit and listen to the moves. Also it is wonderful to meet up with dancers from other countries. I dance regularly to DiGreen and Terry McCann and they have dancers from Germany, Sweden, Denmark, Finland, USA, Russia, Wales, Belgium France and of course us Brits! When Terry ends his tips he always asks 'Are you home?' To which I reply (under my breath) yes Terry I'm AT HOME, but not always in my Home Position. Of course, the beauty of V.D. is that nobody knows if you go wrong, so please don't tell him that I sometimes do! Thanks and Stay Safe.

## **Jim Weber**

### **July 1, 1946 – September 11, 2020**

### **Service to Family, Country, Community & to Square Dancing**



Jim served his family, his country, his local city, surrounding communities and our entire square dance world. We knew Jim Weber best for his involvement in our Square Dance family.

Jim Weber and his wife Edythe have been dedicated members of the United Square Dancers of America's (USDA) Executive Committee since June 1994. During these 26 years Jim committed himself to the furtherance of not only USDA, but to Square Dancing as a whole.

Jim is probably the only man who can say he married an old witch – and not get his head knocked off! Edythe and Jim met while working in a haunted house in October 1985. Edythe was literally the old witch, and Jim fell under her spell. They were married (each for a second time) on February 14, 1986.

Jim and Edythe Weber took square dance lessons that fall and started dancing in February 1987 in Kansas City, Missouri. Leadership is a quality that Jim and Edythe have brought to the square dance world in many capacities. As well as holding many offices at the club level, Jim and Edythe have held the following:

Heart of America Federation of Square and Round Dance Clubs (Kansas City area) 1990-1991 Co-Editor of Fed Facts, 1991-1993 Editor of Fed Facts, 1993-1995 President. 1995-1997 Credentials Committee.

#### **Missouri Federation**

1997 – President of the NW District and delegate to the State Board, 2001-Secretary, 2002-3<sup>rd</sup> Vice President, and 2002-State Dance Chairman, 2003-2<sup>nd</sup> Vice President, and Editor of Show Me Doin's Square Dance Magazine, 2004-1<sup>st</sup> Vice President, and Editor of Show Me Doin's Square Dance Magazine.

After becoming involved with United Square Dancers of America in 1992 as a delegate for the Heart of America Federation, they joined the USDA Executive Committee in June 1994 working with then USDA News Editors Jim and Peggy Seagraves and then transitioned into becoming Editors of USDA NEWS in January 1995. This is a position that they held until 2003, at which time they took a break to step-up and serve as Presidents of the United Square Dancers of America 2003-2005, after which they then resumed their USDA News Editorship again in 2005 until 2012.

Their service to USDA has also included being elected Plains Region Vice Presidents from 2012-2015, +Secretary 2010-2012, Treasurers 2007-2010 and 2016-2017. They have served as Education/ Publications Chairman and Director of Information and have served on the Budget Committee and Audit Committee numerous times. In 2012-2015 Jim and Edythe were elected United Square Dancers of America Plains Region Vice Presidents.

With the entry of USDA into the computer age, Jim was able to utilize his computer expertise to develop and manage the United Square Dancers of America's website from its inception in 1995 through 2020. Over his 25 years as USDA Webmaster, Jim implemented access to all of the USDA programs via [www.usda.org](http://www.usda.org).

### **Beyond USDA –**

Having been in the room when it happened in St. Paul, Minnesota in June 2002, Jim and Edythe have been intimately involved with the birth, development and growth of the Alliance of Rounds, Traditional and Square-Dance (ARTS-Dance) that serves as the gathering place for the ten major dance organizations (All Join Hands Foundation, Ltd., CALLERLAB, CONTRALAB, IAGSDC (International Association of Gay Square Dance Clubs), NEC (National Executive Committee of the National Square Dance Convention®), NSDCA (National Square Dance Campers Association), ROUNDALAB SSDUSA (Single Square Dancers USA), <sup>USA</sup>WEST Square Dance Convention® Policy Board and the United Square Dancers of America to collaborate on issues critical to the promotion of the Square Dance activity. Jim served as the Chairman of the Governing Board of ARTS from 2009-2011 and Edythe has held the ARTS Treasurer's position from 2004-2020. Jim has been the USDA's representative to the ARTS meetings since 2011.

Jim and Edythe have attended 30 National Square Dance Conventions® (NSDC). Their involvement in the NSDC has included serving as Education Chairs for the 2008 NSDC in Wichita and the 2013 NSDC in Little Rock, then in 2018 they were the Housing and Registration Chairs for the NSDC in Kansas City. They have presented seminars and workshops at more than fifteen National Square Dance Conventions®.

Jim retired after 31 years from the City of Liberty Fire Department where he was Division Chief and Director of Emergency Medical Services.

Service was always an important part of Jim's life having served in the Navy during the Vietnam War. As a Vietnam Vet, Jim was active in the VFW heading up their fish fries on a regular basis.

In between square dance activities, they filled their time with family (two daughters and three sons plus four granddaughters and seven grandsons ranging in age from 29 to 15), fishing, camping, hunting, and go to Kansas City Royals games (even when they aren't doing so well). Jim had a passion for woodworking projects and working on computers.

Jim was born July 1, 1946, in Laredo, Missouri, the elder of two children of Herman "Micky" and Marjorie "Rose" (Peterie) Weber. He graduated from Laredo High School in 1964 and soon joined the US Navy. Jim served from 1964 until receiving honorable discharge from active duty in 1968 and reserve duty in 1970. Jim later pursued his Associate's degree at Penn Valley Community College.

Jim was very active in his community. He served as a leader in Boy Scout Troop 374 in Liberty with his son Brad. He was an Eagle Scout and a Firebuilder in the Tribe of Mic-O-Say. Jim was active in Clay County 4-H in shooting sports and fishing projects with his stepsons.

Jim was a Past Commander of VFW Post 4043 in Liberty, serving on its funeral honors team. He sent weekly reminders for breakfast at Ma and Pa's

Along with his parents and first wife Mary Susan Stevens., Jim was preceded in death by a stepson, Grover McGuire, Jr. Survivors include his wife, Edythe; children, Shelly Graham (Bob) of Kansas City, Bradley Weber (Allyson) of Lexington, Tracy Geier (Dicky) and Tim McGuire both of Liberty; 13 grandchildren, 13 great grandchildren; sister, Freida Troester (Richard) of Trenton, two nieces and their families, as well as other family members and countless friends.

Jim was laid to rest on September 16, 2020, at the New Hope Cemetery in Liberty, Missouri with full military honors

We will ALL feel Jim's loss so personally and so deeply because we ALL depended on Jim and Edythe for so very much and knew that we could always count on both of them to be there for us anytime we needed them. Jim was always there for Edythe, and Edythe is still there for Jim and all of their family.

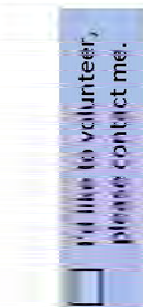

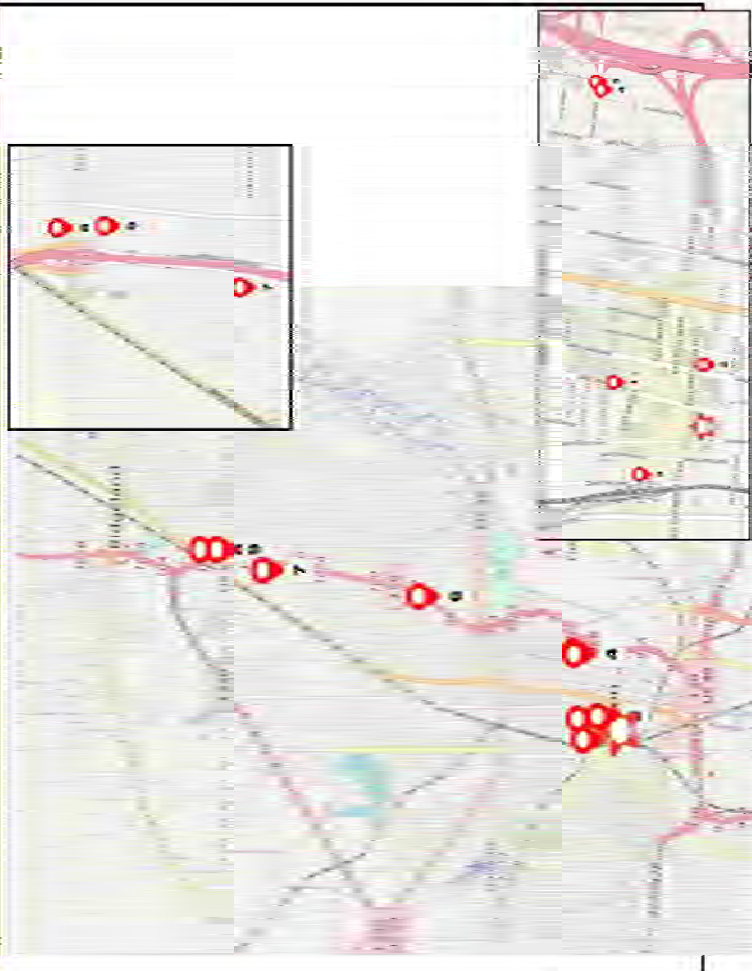
